STATEMENT OF CHANGES IN ACTIVITIES and SOURCES OF FINANCING *

In February of 2019, a Full Faith & Credit bond was issued for \$8,225,000 for purposes of building a Skills Center and Campus Housing at The Dalles campus of Columbia Gorge Community College. This is the reason for the large change in the adopted budget ending fund balance and the projected beginning fund balance for the 2019-20 A State Grant will be provided and total project cost is estimated at \$14,600,000. A State Capital Projects fund was established for this project. Another \$1,500,000 in financing with the Port of The Dalles was authorized in March of 2019. Funds are expected to be received in the 2019-20 budget year, but payments will not be due until the 2021-22 fiscal year.
