# **Recognizing & Reporting Child Abuse & Neglect**

In Oregon, child care providers and early childhood educators are required by law to report child abuse and neglect. As a mandatory reporter, you are the crucial link in the child protection system. Learn about the signs of abuse and neglect. Learn what to report, how to report it, who to call to report and who will respond to the report. This class can be repeated to count toward Office of Child Care license renewal as follow: Registered Family Child Care, once every 5 years and Certified Center/Certified Family Child Care, once every 3 years. This is a Set One in Health, Safety and Nutrition class.



# **News Update**

# Improvements were made in the Employment Related Day Care (ERDC) program starting October 1, 2015

The information below lists ERDC changes families may qualify for.

- All ERDC cases will be certified for 12 months. Twelve month eligibility is designed to benefit the child. Staying with the same provider over a long period of time has been proven to be beneficial to child development and family stability.
- Families can earn more than before to stay in the ERDC program. Income limits for entering the program have not changed but income limits for exiting the program have been raised. Once approved for benefits, families would not be over the income limit until they reach the new amounts chosen.
- Copays and authorized child care hours will be more stable. Copays and hours will only be adjusted in limited situations; hours will not be decreased. Providers should only bill for hours the children are in care at the home or facility or for eligible absent days.
- There may be instances when a zero copay will be listed on the billing form. This may occur when a parent/caretaker is temporarily unemployed or during the military transition period. Work search is allowed in these situations.
- Cases will be less likely to close. Short-term changes in employment or wage increases during the ERDC certification period will not cause the case to close. Children can stay with the same child care provider even when the parent may be temporarily unemployed. Work search is allowed during this time.
- ERDC may cover some student hours for working families. This will benefit families who are working and enrolled in a higher education institution that is eligible for federal financial aid. The parent must be in a program that will improve their employment opportunities. Combined work and student hours may be approved for up to 215 hours per month. The student hours cannot be more than the work hours.
- **Self-employment hours may be covered.** This includes families who are solely self-employed. The total child care hours may be approved for up to 215 hours per month.

# Noticias Actualizadas

## El 1 de Octubre de 2015 se realizaron mejoras al programa de Cuidado Infantil Relacionado con el Empleo (*Employment Related Day Care* o ERDC).

La información que aparece a continuación indica cambios en el programa de ERDC para los cuales podrían calificar ciertas familias.

- Todos los casos de ERDC estarán certificados por 12 meses. La elegibilidad de doce meses esta diseñado para beneficiar a
  los niños. Permanecer con el mismo proveedor durante un periodo largo ha demostrado ser beneficioso para el desarrollo
  infantil y para la estabilidad familiar.
- Las familias pueden ganar más que antes y permanecer en el programa de ERDC. Los límites de ingresos para ingresar al programa no han cambiado, pero los límites para mantenerse en el programa han sido elevados. Una vez que se aprueban a las familias para recibir beneficios, éstas no excederán el límite de ingresos hasta que lleguen a las cantidades que se han indicado.
- Los pagos compartidos y las horas de cuidado infantil autorizadas serán más estables. Los pagos compartidos y las horas se ajustarán únicamente en situaciones limitadas; no se disminuirán las horas. Los proveedores deben facturar únicamente por las horas que los niños estén bajo cuidado en la vivienda o en un centro o por los días de ausencia elegibles.
- En ciertas instancias, el pago compartido podría aparecer como cero en el formulario de facturación. Éste podría ser el caso si uno de los padres o el tutor está temporalmente desempleado o durante el periodo de transición militar. Está permitido buscar un trabajo en tales situaciones.
- La probabilidad de que los casos cierren será menor. Los cambios de corto plazo en el empleo o el incremento de salarios durante el período de certificación de ERDC no harán que el caso cierre. Los niños pueden permanecer con el mismo proveedor de cuidado infantil incluso cuando el padre/la madre esté temporalmente desempleado/a. Está permitido buscar un trabajo durante este tiempo.
- ERDC podría cubrir algunas horas de estudios para las familias que trabajan. Esto beneficiará a las familias que trabajan y que están matriculadas en un centro de estudios superiores que sean elegibles para ayuda financiera del gobierno federal. El padre/madre debe estar matriculado/a en un programa que mejore sus oportunidades laborales. Puede aprobarse un total de hasta 215 horas de trabajo y de estudios combinadas al mes. Las horas de estudios no pueden superar las horas de trabajo.
- Las horas de empleo por cuenta propia podrían estar cubiertas. Esto incluye a las familias que trabajan únicamente como independientes. Puede aprobarse un total de hasta 215 horas de cuidado infantil al mes.


