CGCC Welcomes New President Dr. Marta Yera Cronin

Back in the 1970s, Washington Heights on Manhattan's west side was one of New York City's tougher neighborhoods. Violent crime, already commonplace, had worsened with the crack cocaine epidemic.

But Marta Yera had two kids to raise, and she knew hard work and education were their tickets to safer places. A native of Catalonia, Spain, she had moved to Cuba, where she became an activist against the Castro regime. Warned of imminent danger, her own mother spirited her out of Cuba one step ahead of Castro's secret police, first to Costa Rica, where she worked as a maid, then Miami before arriving in New York. Her husband, whom she had met in Cuba and reunited with after her escape, left the family when their daughter - named Marta Maria, after her mother - was only five. She worked multiple jobs, first in a clothes factory, while saving enough money to give her daughter and son a good education.

"My mom used to say: in this house it's God, me and your teachers...in that order," recalls Dr. Marta Yera Cronin, who on July 1, 2018, became president of Columbia Gorge Community College. And her mother's emphasis upon the value of education became advice that Marta, the daughter, followed all her life.

Born in New York, Marta Maria dreamed as a young girl ("with a concrete sidewalk for our lawn") of owning a country grocery store, but those dreams soon turned to the study of language. Since she was already fluent in Spanish, "I wanted to learn something I didn't already know," so she mastered French, then studied Russian for her bachelor's degree. By now, she had relocated to Miami.

She never thought of teaching; her goal was to return to New York City as a translator for the United Nations. But, in the meantime, she had to earn a living, so she took a job teaching at a private middle school ... only to find that many of her students didn't know how to read.

"You think these kids can read, but no. Why should they be at a disadvantage?"

It was a life-altering discovery for Marta, who changed her master's to reading so she could better teach her students this fundamental skill. "The rest is history." She did put her knowledge of French to use, teaching students from kindergarten through eighth grade while she began work on her doctorate, but now with the goal of becoming

a professor with an emphasis on teacher education.

"I'd never intended to go into higher education," she added, ironically. But her dissertation chair encouraged her to apply for jobs in the field as a way of broadening her experiences. One of those job openings was as a faculty member at Indian River Community College, in Fort Pierce, Florida, which was not yet a state institution.

"I was totally shocked when they offered me the position." She accepted, starting as a master instructor, then working her way up over 17 years to become a full professor. She became a dean, after 11 years, when the college president asked her to develop several new programs ... starting the very next day. Indian River's new designation as a state college created that opportunity, much as Columbia Gorge Community College's successful quest for independent accreditation also brought greater academic flexibility.

She learned of CGCC when a colleague sent her the job announcement. "Someone said, this is what you've been looking for, a Hispanic Serving Institution, a small institution that I can help grow."

There are some parallels between Indian River and CGCC: A nursing shortage which both institutions have helped address, long travel distances from the nearest universities, and the ever-present link between a robust economy and college enrollment: As the economy strengthens and people find jobs, enrollment often declines. As it declines, tuition revenues falter, making it difficult for colleges to be prepared for the next economic downturn.

But there are differences, too. Indian River enrolls 25,000 students with a population base of just under a million. CGCC has fewer than 1,000, with 80,000 people across a region the size of Massachusetts.

But there's one difference that especially troubles Marta.

"I don't like that we're not the first go-to for high school students," she said. "We're offering affordable, quality education. We need to establish a greater level of comfort with Columbia Gorge Community College before students graduate high school. Students go to university for a year, but what happens when the money runs out? What do they do then?" Marta knows CGCC offers a better option, whether students are

seeking a four-year degree or an industry-recognized certificate through one of the college's shorter-term, workforce training programs such as computer science, business administration or electro-mechanical technology.

"I was the only Hispanic administrator at my institution in Florida," Marta explains. As a first generation American, a first generation college graduate, and a teacher who discovered her career in giving middle school students the gift of reading, she knows that the earlier students learn about college, the better their chances of escape from poverty.

"There's this gap. Where do they go? It's a social responsibility. You want students to be engaged. Reach them when they're young, still in middle school - all students, not just Latinos." Marta quickly learned that faculty, staff and college directors at CGCC shared that commitment. "When I came here, I felt this passion in the questions people were asking me," she said. "They want to make a difference."

As the college's third president in its 41-year history, Marta is learning about the institution, its organization, its regional communities. Although she had always wanted to live in a rural area, the Columbia Gorge is her first experience. And in the issues confronting rural education -- especially in distance learning -- Marta finds a challenge she didn't have in Florida, where high-speed internet access was taken for granted.

"We need to supply technology to reach these places. There are so many possibilities, but they have no connectivity."

She also wants to grow the college's foundation, knowing that its capacity to confer scholarships creates a vital bridge for students growing up, as she did, with limited family resources.

Apart from her new role at the college, Marta and her husband Mike, whose own background centers on solar and telecommunications technology, plan to enjoy the beauty of their new surroundings. They like to hike and bicycle, and are looking forward to tackling the trails of the Columbia Gorge, far removed from Florida's flat terrain. They have two children, ages 20 and 23, and two rescue dogs.

And, Marta likes to find a quiet corner to enjoy her favorite pastime: She likes to read.

An Explanation of Fees for Credit Classes

Course Fees: Some courses include a fee that covers additional instructional costs for that class. These may be charged on a per-course or per-credit basis, and are listed with the specific class to which they apply.

Lab Fees: Lab fees are charged for classes that have supplies and materials used by students each term for specific classes.

Program Fees: Program fees are charged for limited entry programs that have higher operational costs.

Service Fees: Service fees are universal fees charged per credit intended to replace fees such as student activity fees, technology fees, and parking fees.

Paying for Classes

Payment is due on the first Friday of the term, unless a payment arrangement has been made with the business office.

Late Fees

Late Fees will be assessed at a rate of 10% of account balance, up to \$75, if paid after the first week of term.

Financial Aid

Federal and State Aid

The Financial Aid Office at Columbia Gorge Community College can help you start your search for financial aid and help you through the paperwork required for Federal assistance. The Free Application for Federal Student Aid (FAFSA) application should be filed as soon as possible after October 1st each year and can be completed online at www.fafsa.ed.gov. The process can take 8-12 weeks from start to finish, so be prepared and file early. The earlier you file, the more benefits may be available to you.

2018-19 Award Year

The 2018-2019 award year begins summer term 2018. The FAFSA is available now at www.fafsa.ed.gov. When filing your Free Application for Federal Student Aid (FAFSA), use CGCC's school code (041519) to receive Federal Financial Aid at CGCC. The application for 2019-20 will be available October 1, 2018.

The ORSAA is an alternative to the FAFSA for undocumented Oregon students, including students who have DACA (Deferred Action for Childhood Arrivals) status. The ORSAA opens in October each year. Do NOT complete the ORSAA if you are a U.S. citizen or a legal noncitizen with an Alien Registration number. For more information please go to <http://oregonstudentaid.gov>.

Registration does not require a financial aid award letter in place at the time students register. Students

may select "pay later" on the screen which asks if they are paying for classes at the time they register. If the financial aid process is not completed, or the student is not awarded funds, the student is responsible for full payment.

Computer access and assistance with online filing is available in both The Dalles and Hood River. Students may also schedule an appointment to discuss their financial aid progress by calling Student Services at (541) 506-6011 or by emailing the financial aid office at financialaid@cgcc.edu

How to Take Classes

If you are a new or transferring student, please see the steps to becoming a student on page 6. If you are a continuing student, check your "OK to register" in My Program Planner and see the chart on page 3 to see when your registration window opens.

Charges

Charges are applied to a student's account when the student registers for a class. All of the tuition charges associated with a class will be removed if the student officially drops **within the refund period**. Some lab fees are non-refundable. No charges will be removed if the student drops after the drop deadline.

Drop Deadlines For Credit Classes

Credit classes must be dropped online, through MyCGCC. Responsibility for drop or withdrawal from a class within the specified timelines **resides with the student**. If a credit class is not dropped within the drop period, it will result in a "W" grade on the transcript, indicating a Withdrawal, and no charges will be refunded. Drop deadlines for full tuition refund are as follows:

Students are entitled to a 100% refund, except for non-refundable course fees, when a course is dropped during the following deadlines:

- 8-12 week classes: drop by the end of the first Friday of the term.
- 2-7 week classes: drop by the end of the first day of the class.
- Less than 2 week classes: drop before the first day the class meets.
- **No refunds will be given after the deadline.**

No-Show Policy

Students are expected to attend all class sessions, and to log in to online and hybrid classes. Students who do not attend the first class session or who do not log in and show activity by Wednesday of the first week may be dropped from the class by the instructor. Students will receive an email if they are dropped from a course for this reason. Students must contact the instructor for permission to be added back to the class.

Learning Communities at CGCC

What is a Learning Community?

A Learning Community (LC) is a group of courses designed specifically to enhance student success. Learning communities allow for greater mastery of academic material, and enhance connection between students, faculty, and the greater college community. Students enrolled in learning communities partake in these grouped courses in a cohort model of learning - that is, the same students take the same courses for fall and winter terms of their first year at CGCC.

Why join a Learning Community?

BETTER GRADES | Students enrolled in CGCC's Learning Communities earned almost a full grade higher than their peers not enrolled in the Learning Communities. With time set aside in the Learning Community lab (workshop), students not only get direct access to faculty, but also peer-to-peer academic support.

DEEPER UNDERSTANDING | Students continually praise the Learning Community model as essential for academic mastery. Additionally, it allows first time and returning students to acclimate to the college environment. Starting school can be scary, stressful, and exhilarating - our Learning Community faculty understand this, and are here to support your transition to college. We want you to achieve your goals, and participating in a Learning Community can assist you in reaching each of them.

GREATER CONNECTION | Learning Community students speak highly of the friendships they make in the cohort model (where they study with the same group of students for two terms). In addition, they cite feeling more deeply connected to and supported by their faculty and the greater college community. Learning communities offer the chance for faculty to get to know your learning styles, strengths, and challenges in a way that is often impossible without the dedicated time of the LC.

CONTINUED SUCCESS | Students who feel engaged in their coursework and classroom communities continue with their studies far longer than students who do not have this experience. Learning communities help you successfully fulfill all of your dreams. This is just the beginning.

Fall Learning Community

In fall term, students co-enroll in Introductory Writing (WR 90), and Transformative Reading (RD 90). Additionally, Learning Community students meet for three hours a week outside of these classes in a free, one-credit workshop-lab (ALC 51) where they work collaboratively to further digest their assigned work.

Winter Learning Community

During winter, the Learning Community cohort continues to meet in workshop (ALC 51) as they progress to the next set of grouped courses: Intro to Expository Writing (WR 115), Critical Reading (RD 115).

By the end of winter term, students are prepared for transfer-level courses and may choose to continue their foundational studies in English Composition (WR 121).

But what do learning communities really look like? Feel like?

Academically: Academic material and skill-building between your three courses may - and will - often overlap. For example: You show up to your college success course and learn how to take three different types of notes. When you arrive in your reading class, you learn how to critically engage texts through annotation (another form of note-taking). Finally, you arrive in your writing class where you are asked to read and respond to an essay - and, here, you can pull from your various new skill sets of note-taking and text analysis to actively understand the craft writing.

Socially

We spend a great deal of time together in our cohort (co-enrolled group of students), and often times, people develop foundational relationships to serve them through their courses. Time and again, studies show that it is not money that creates student success. It's people. In fact, the largest study on community college student success showed that the most important signifier of student graduation was having someone to support them. Think of your peers in Learning Community as this support.



The AHA Instructor Training course is a 4-step process:

STEP 1: REGISTER FOR THE COURSE.

STEP 2: SEND AN EMAIL TO THE CGCC

INSTRUCTOR:

You will be sent specific information on next steps in preparation for the ONLINE and IN-CLASS Discipline Specific Training portion of the course, including textbook purchase information. BE AWARE THAT THE ONLINE PORTION HAS AN ADDITIONAL PURCHASE COST. The instructor can answer your questions.

STEP 3: DISCIPLINE-SPECIFIC TRAINING

This part of the course is completed in 4-hour and 8-hour classroom sessions with other instructor candidates to become familiar with the AHA course options, materials, equipment, outlines, and teaching methodology. You will also demonstrate your ability to correctly and effectively perform CPR and use the AED. Textbooks are required and must be brought to class.

STEP 4: TRAINING CENTER AFFILIATION AND MONITORING/MENTORING

To complete the Instructor Training program, you must affiliate with a Training Center (TC), meet with the TC coordinator or lead TC faculty to discuss specific TC administrative policies and procedures, and then be monitored by a TC Faculty member while teaching your first class. How Can I Pay?

CGCC accepts cash, checks and VISA, MasterCard & Discover bank cards.

When is Payment Due?

- First Friday of the term. If you enroll after that date, payment is due upon registration. If you have financial arrangements that will not cover the full term charges, you must pay the difference by the due date.
- For non-credit classes, full payment is due at the time of registration.

What If My Account Is Past Due?

Past due accounts are assessed a late payment penalty of 10 percent of your account balance, up to \$75. Holds are placed on past due accounts, restricting future registration and transcripts. Past due accounts are referred to the Oregon Department of Revenue or other outside agency, and may be subject to additional collection charges, attorney fees and credit impairment. The college reserves the right to withdraw you if your account becomes past due or has an unpaid balance from a prior term.

What Are My Payment Responsibilities?

You are responsible for full payment of all charges on your account by the payment due date, even if your account is being paid by another party. You are responsible for keeping CGCC informed of any address and telephone changes. Even if you are under 18 years of age, you will be held liable for any charges on your account under ORS 348.105. When you register for a class, you are liable for payment of the charges on that class, whether or not you attend. To have the charges removed, you must personally drop the class by the drop deadline.

How Can I Pay In Installments?

The Installment Plan allows you to pay half of your tuition and fees by the first Friday of the term, and defer the balance until the sixth Friday of the term. To qualify for the Installment Plan, you must have a satisfactory payment history, and a zero account balance. CGCC may deny or rescind an Installment Plan if you miss the required payment due dates, provide inaccurate or incomplete information, have a poor credit history with the college, or do not meet the eligibility requirements.

How Do I Pay With My Financial Aid?

If you have received and returned your award letter, financial aid awards will be posted to your account. If your award exceeds your account balance, you will receive a refund check by mail. If your award is not enough to cover all term charges, you must pay the difference by the first Friday of the term. If your aid is delayed, inform the business office at (541) 506-6057 as soon as possible.

How Does My Company Or Agency Pay?

Arrangements for payment by an agency or company must be approved by the college before the term starts. Once arrangements have been made, take your payment authorization to the Business Office, or fax it to (541) 506-6052 before the term begins. The student is responsible to ensure that a payment authorization is on file by the payment due date, and for payment of any unpaid charges and late payment penalties.

How Are Scholarship Awards Applied To My Charges?

CGCC Foundation scholarship awards are posted to your account. Scholarship checks from private donors, service clubs, or schools are posted to your account. You are responsible for charges that exceed your award.

Discounts

Discounts for District Residents, age 65+

District residents of Hood River or Wasco Counties 65 years or older are eligible to receive a 50 percent tuition discount on both credit and adult continuing education classes on a seat available basis. Check the course description for eligibility since some classes may not allow tuition discounts. Discounts do not apply to full classes or to lab and other class fees. You will be notified if the class is full and the tuition discount will not apply. Request your discount at the time of payment or by calling the Business Office at (541) 506-6057.

Oregon Senior Option

Oregon residents 65 years old or older at the beginning of the term in which the course is offered are eligible for a 100% tuition discount to audit a course if the following conditions are met:

- Students will complete a Senior Tuition Waiver and Audit Request form with instructor signature.
- Senior option enrollment will be on or after the first day of term.
- The course must be a lower-division collegiate course.
- Senior Option students will not displace paying students.
- The maximum costs to be covered by an approved tuition waiver each term is the cost of 8 credits.
- All course fees are to be paid by the student.

Refunds, & Removal of Charges

Refund Requests Within the Drop Period:

The Business Office automatically issues refunds to students who drop within the drop period. The refund process as follows:

- Refunds from tuition and fees are first applied to outstanding charges on the student's account. If the student receives financial aid and opted to charge books on his/her account, this will also be deducted prior to any refund.
- If the credit is the result of a payment by check or cash, a check is issued in the student's name.
- If the credit is the result of a bank card payment, the refund will be applied to the original bank card.
- Refunds resulting from check overpayment are held two weeks from the date of the original payment.

Refund Requests After the Drop Period:

If an extreme hardship prevented you from completing a course, and you could not drop during the refund period, you may request to have tuition charges removed from your account. Fees, especially any non-refundable lab fees may not be refunded. A Tuition Appeal form for requesting a refund can be obtained from the Student Services office in The Dalles or Hood River. You will be asked to provide documentation of your circumstances to support your claim. Your petition, and all accompanying documentation, must be received by the filing deadline to be considered. Please see the form for more details.
